'REPORT BACK' By Vicki R. District 5 DCMC

Before I get down to the 'nitty-gritty' of my **2024 Pacific Regional Forum** (PRF) 'report back' allow me to, once again, thank you District 5 members for allowing me the opportunity to attend this year's forum in Las Vegas, Nevada. I'd also like to thank Mitchell B. for providing the members during our July meeting with a bit of its history, along with what it is all about. It was a pleasant surprise, filled with gratefulness, to hear as I was "Zooming" in from my hotel room while, I admit, lying in bed.

Driving to Las Vegas versus flying was just what I needed. Because it gave me a few hours to de-stress, let go of what all I had committed to do for others and, I admit, selfishly focus on myself, and the scenery around me...traffic included.

 - Due to the manufacturer discontinuing to make literature racks, AAWS will be discontinuing the selling of them once they run out of the 100 they have in stock. They are looking into other options.
 - General Manager Bob W., GSO GM
 - Current 2024 GSO headquarters (475 W. Riverside Drive, New York City, NY) has been leased for another 10 years. This is its 7th location. (Moved there in 1992.) The GSO board meets 3 times a year. He has 14 direct reports, 2 assistants (Jacob & Pamela), a GSO staff meeting every Weds., and meets with the GSB Chair every week. He showed a picture of "Reinhold Niebuhr Blvd" in New York named for the man who is considered to be the originator of the "Serenity Prayer", along with slides of the 11 GSO departments.

• GSO Staff - Racy J., Staff Coordinator

Is a "Special Worker" as mentioned in Tradition 8. Has 12 listed staff assignments. Also serving as "?" staff secretary.
 * Corrections: 500 AA meetings in jails and prisons.

Due to District 5 having not conducted one in over 10 years, I chose the "Inventories:..." workshop. Based on the number of attendees, including those who had to stand, it was obviously a workshop topic that many others wanted to know more about also. The moderator asked us what questions we may have, and some of the ones mentioned were:

- 1. "What do we do with the inventory?"
- 2. "When to do the inventory?"
- 3. "Are we reaching the still recovering alcoholic?"
- 4. "How to do the inventory?"
- 5. "How to find someone to facilitate the inventory?"
- 6. "How long of an inventory how many questions?"
- 7. "Should the Area handle the district's inventory?"
- 8. "How can the Area be more involved in GSO inventory?"

Some of the comments, suggestions and/or answers from attendees were:

- 1. "If you come with a problem, come with a solution (i.e., GSO 'suggestions')."
- 2. "Have a good note taker."
- 3. "Have an outside facilitator.
- 4. "An outside facilitator does not offer solutions or ask questions."
- 5. "Group discusses questions and answers."
- 6. "Form an ad-hoc committee to go through the group's answers, prioritize once done, and then bring back to the group."
- 7. "Inventories can be published on applicable website, pdf versions emailed, hard copies provided, and/or have a link in newsletter."
- 8. And lastly..."GSO does not have information or a pamphlet on 'inventory process'." (*This one definitely caused quite a chuckle amongst the attendees.*)
- 9. "Suggest reading A.A. Group pamphlet."

Unfortunately, because the workshop was only an hour, there was not enough time for additional discussion. But I did walk out knowing more than I did when I walked in. So be prepared for a future District 5 inventory.

- Big Book 73 languages. The 74th language is almost done.
- Other Items 110 languages
- Showed a world data map reflecting AA presence.
- 1962 "World Service" meeting formed 6 zones within AA (World).
- Cuba At one time AA had to be conducted via the Catholic Church only. Meaning, AA had to be recommended to the alcoholic by a Priest.
- The first "Redela" (Spanish for "Meeting of the Americas") was in 1979. At that time there were 10 countries that were involved with the AA fellowship that year. (*Per the 2018 / 25th World Service Report, there were 25 countries involved.*)
- There is an "International Fund" for literature.

• GSB Treasurer's Report - Kevin P., GSB Treasurer / Class A Trustee

 \circ **2023:** 7th Tradition contributions were \$10.84 million. Up 2.8% from \$10.55 million in 2022.

• Cost of Program Services per Individual: \$6.43

- **Self-Support:** Covered 62% of operating expenses.
- Grapevine Subscription: Paid print income decreased 12% in 2023. Online income increased 72% due to app, etc.
- **Contributions:** Group 54.5% / Individuals \$32.7% / Areas & Districts \$5.5%
- **Expense:** Salaries 46% / Payroll Taxes & Employee Benefits 13% / Professional Fees 10% / Data, Automation & Website 3% / Facility & ?
- Reserve Fund: Concept of GSB's "Prudent Reserve" not the same as in your group's.

• First-Time Attendees Sharing Session

 Long line of first-time attendees sharing. It was wonderful to hear them share. And it was a wonderful reminder of my having been a 'first-time' attendee.

- Various Q&A and Comment Opportunities throughout Friday & Saturday and Sunday's "Ask it Basket":
 - \circ Q: Why are contributions not being accepted via "app" (meeting guide)?
 - A: GSB is looking into it. Cost effectiveness, various platforms, etc.
 - \circ Q: What is the cost to AA taking over other "url" website?

A: No cost to AA. The owner of other the "url" understood the harm that was being caused by those searching "Alcoholics Anonymous" and ending up on the wrong AA website.

- Based on the way an attendee used the words "Administrative" decision in regard to the Plain Language Big Book: Clarification: It was not administrative decision. It was approved at the GSC based on the many, many group consciences.
- How is the number of "2 million members" determined?
 A: GSO based on group's updating their GSR info, number of members noted on form, etc.

$\,\circ\,$ Q: 2025 International Convention – How do you get across the border if past law issues?

A: Current information is in the Box459 (Spring 2024).

 \circ Comment by an Area Treatment Chair: There are 4,440 Drug Courts, and approximately 12 million in treatment.

"<u>Ask-it-Basket</u>"

- Q: Where's the next PRF?
 - A: San Diego, CA Dec. 4 thru 6, 2026
- C: Many people feel it would be beneficial to move headquarters.

A: Current building is only available to non-profit. Based on that, the rental is 25% (approximately \$25 per square foot) of the average building rent in the city.

- **Q: Can a PR staff member participate in a Western PR forum?** A: Yes and will – by invitation.
- \circ Q: When will the Plain Language Big Book be available?

A: Final edition edits are being completed. Printing date, hopefully, November 1st. Available date, hopefully, December.

• Q: How long can a GSR serve in that position?

A: Up to the group conscience. GS will not give answer.

 $\circ\,$ Q: Where do we see the future in AA Technology?

A: The vision is the "What If?" scenario. From that "What If?" scenario, will then discuss ways to address that, make that work, etc.

In ending...

What an amazing 'learning experience' event. I will say though that I'm glad this '24/7' coffee drinker brought her own coffee and coffee pot, as paying \$6 a cup numerous times a day is not something that I'm comfortable with. I have no doubt that what the hotel lacked in 'alcohol' sales from the attendees, they made up for with 'coffee' sales.

I loved the camaraderie between Scott and Mark! It was obvious by the way teased and joked back and forth with each other, that they were great friends and had a great AA related working relationship. They definitely caused the attendees a whole lot of smiles and laughter.

There were 918 attendees at the forum. And, of those, 588 were first timers. So, out of curiosity, I checked to see what the attendance had been at my first forum in 2018. Surprisingly, it had the exact same number of attendees. Only that one had 634 first timers. I, as the D5 Panel 68 Treasurer, along with the D5 Panel 68 DCMC, and the D5 Panel 68 Registrar, being 3 of them. It's hard to believe that one was 6 years ago. But, if all goes as I hope and pray it does, it will only be 2 years until I attend the next one, because the 2026 PRF will be held at the "**Wyndham San Diego Bayside**" in **San Diego, CA – Dec. 4**th **thru 6**th.

And, although it's 2 years away, I do hope that some...all...of you will take the opportunity to get to learn more than you know by attending it. Registration is free!!
