Registrar (**Kyle B.**): Kyle was absent but had Greg A cover for him and that Kyle stated that he has caught up on all the new groups and got them registered with the area. For tonight's meeting, there were 14 in attendance and 2 on Zoom.

COMMITTEE REPORTS:

Archives (Mitchell B.): Mitchell mentioned that September of this year is the celebration of 65 years of Area 05. The official formation date is September 7th, 1958. Directly from the recording from Mitchell, "Let me give you a little bit of the history. On September 7th, 1958, the Area 05 Service Assembly in Santa Ana elected a new delegate area. So, it was carved out of what was then known as California Southern Area. So, prior to Area 9, Southern California Area was everything from the Kern County line down the Pacific to the San Diego County border, and then from the Pacific all the way to mostly Arizona, Bakersfield, Blythe, San Bernardino, Riverside County, Los Angeles County, San Luis Obispo, Santa Barbra and all of that was Southern California Area but it started in 1958 then grew to what it is today. The new delegates areas terms start on even years. So, delegates are elected one year from half the area then the second half are elected on even years. And, since the original Southern California was an odd year, our area agreed to be an odd year because San Diego was also an odd year. This gave California area 5 delegates. Now we have 6 because we've added additional. The new area, officially, was designated Southern Coastal California. The nickname was panel 2 because we were like a little brother to Los Angeles. Just prior to this split, the entire Southern California organization was divided into 33 districts, approximately 266 groups Again, this was 1958. Ten of those districts, like districts 20 through 29 of what was Southern California groups would become this new area which is roughly the geographic area that we have now. There's been a lot of changes in the boundaries over the years. In the very 1st roster in 1958 there were 90 registered groups in our area, and in less than a year that had grown to 105 registered groups, and every registered group had a GSR, and that trend would continue until the 1960's. An important thing to remember is Area 05 was formed because GSRs in these 10 groups came together on September 5th, 1958, and voted to form a new area. The work had begun in 1956, not to get approval from General Service Office, but for General Service Office to say, if the area understands the role of service and you're willing to support a general service structure. Whatever the vote is, they would support it. So, originally it was 105 groups. Actually, to be exact, 90 groups. Those GSRs who showed up and voted, formed a new area, and then out of that they elected a delegate, who was also the chair. They elected a secretary, who was also the treasurer. So, there was only 2 or 3 people in service, very small organization in 58. We didn't officially begin as an area until January 1959. Again, we elected our service members. We began. So technically, this is the 65th year. Now, I realize that's a lot of detail, but I have handouts on the table, and I would recommend taking this back to your groups. Because if you're interested, there's a pamphlet on how AA Came to California. That's the story that we tell. We've got 65 years of Area 9. That's back to the beginning, including a much longer description of this. The 1st meeting of Alcoholics Anonymous on the West Coast. That's a great trivia question. Where was that held? And the answer is not Los Angeles. The last one is 1951. When the General Service Conference was about to begin in the next year. There was an election held in Los Angeles, and it's the history of that 1st election. And if you're a history buff, you'll recognize a lot of names. The people who are early AA in Southern California were there. And it's the whole story about how they elected a delegate. And if people ask the question like, oh, these things were all predestined. Nope. Did everybody agree on the outcomes? Nope. Were people happy about forming the conference? No. But we took an action. We followed through with it. And the results change people's minds. So, take that back to your groups. Because if you're not happy with the way things are now could be, we just need a little bit of time to see how they work themselves out, and if it was a bad idea, you can always change, go a different direction. But our history has shown that people took some risks early. I'll call us anonymous, and that's how we form the structure. If you're interested, those materials are also available off the archive's website. But thanks."
