DCMC (Vicki R.): Good evening, everyone! My name is Vicki R., I am your alcoholic District 5 DCMC. And I'm grateful to be surrounded by all of you sober 'being of service' alcoholics. I'm happy to report that the District 5 Inventory questionnaire was approved during our Monday night Steering Committee meeting, that it has now been finalized, and that it is now the "Program" portion of tonight's meeting. Based on the latter, I'll move onto the following portion of my report.

- 1. 74TH GENERAL SERVICE CONFERENCE FINAL REPORT: An order of 5 hard copies was placed with Mitchell B. right after the ending of our Sept. 12th meeting. I'll have him give you an update as to when they may be received.
- 2. AREA NEWS: The next Area meeting is an ASC and is this Sunday, Oct. 13th, at the Long Beach City College Bldg. "T" / Rm "T-1200" located at 4901 E. Carson Ave., Long Beach. This meeting is the "Q&A" opportunity for any applicable motions that were submitted and made part of the meeting's agenda. He went over July's minutes and explained the situation with them. He stated that his OneDrive kept deleting the saved minutes. COMMITTEE REPORTS:

Archives (Mitchell B.): Good evening. My name is Mitchell. I'm an alcoholic, District five archivist. I made some pamphlets at the table from last month. I brought in a lot of material last month, so I sort of apologize for the volume, but a lot of it is history of Area 09. One pamphlet in particular, actually originally from Area 05. They did the original printing in 1986, and we've been reprinting it. It is the origin of how Alcoholics Anonymous started in Los Angeles, which sounds a little bit like myth, except it's based on real people, and we can verify dates and times. It is an odd story, and it is an interesting thing to share with your groups. Having said that, I am working on the Servathon for next month with the area Alternate Delegate. We will have a room in the facility which we will share about the 1951 General Service Conference. An important feature about the first General Service Conference. It was the first time an A.A. conference was being held. We had a delegate from Los Angeles attend, part of one of the early areas to elect a Delegate, and one of 38 people who were part of the conference at that time. In numbers relative to today, there were 134 voting members at the 2024 74th GSC, so 1951 was much smaller. But the details that the conference established and the structures we recognize to this day started with the 1951 conference. There were only six agenda items for the very first and one of them was actually create a review for literature and then determine what literature would be published by General Service Office. Hence the phrase "conference approved literature" actually began in 1951. One of the very first considerations that they looked at and approved in 1952 was the printing of a project that Bill W. was working on, which turned out to be the 12 Steps and 12 Traditions book. So that was actually the first book approved for the General Service Conference. In 1951 they approved Bill's project. In 1952 delegates saw and reviewed the edition (manuscript), and it was approved for printing, and then it was released, distributed in 1953. You'll be able to see some of these original documents in photocopies from the conference. And I don't want to give away a surprise, but if you come, bring your camera, you'll be able to take a photograph of something that's A.A. specific. People will like it. I will stop at that point, because I do want to make it seem like a "cliffhanger", but people are going to like it. So, you know, please attend. The Servathon is meant to get an opportunity to understand how committees work for those who have general service works, and the Archives would be bringing histories of the area and the way we do services.

Grapevine (Chris D.): Hi, everybody! Chris. Alcoholic. Good to see you here. Good to be here. Good to be seen, not viewed. Alright. So, for this month, for our grapevine. Everybody knows what grapevine is. Right. It is a monthly worldwide magazine in print or in digital copy. If you do not already have the app then take out your smartphone and go to all lowercase, aagrapevine.org and download the app for grapevine, it's free. It will let you elect, if you would like to add things on for purchase, but the general app is free. You can access archived issues; Pam was a great example to talk

about that. She was able to access some old issues that she had written in. And speaking of, which grapevine is always looking for new stories to publish, we all have a different story, guys. None of us have the exact same story. I know for myself, I've had some downtime this past year and it ran through my mind a lot, but I didn't push the button yet, but I think that we should all start considering getting our stories on paper and get it into grapevine, because we never know who whose lives we can affect or touch. So, there are stories in here, tons of them. You could take your step work and turn it into your story that way. You're not forced to write a long story, just a suggestion. That's what I want anyways, moving forward. That is also where you could locate the address. The site to upload your story is at aagrapevine.org, and it will navigate you through. If you have any issues, questions, or concerns, I'm happy to be of assistance. Grapevine has a workbook for grapevine reps and meetings. I'm a district grapevine rep, but there's a workbook for a meeting level and district level that could help you navigate with resources, reaching out suggestions and just everyday tools that you could be using to keep your meetings in touch with, and all the good news that's going on. Grapevine app has a link for the International Convention, so you could do all your booking through your grapevine app. 1st International Convention is not for free, but the link is free to get you to the International Convention. I can't push enough, but I know I mention this monthly, and we are nearing the end of the year. There is a Carry the Message Project through grapevine, and it is gifting a grapevine subscription, either digital or in print, to a facility of your choice. It will be a tax write off for you. They'll get a receipt to where you could claim that on your taxes as a donation to the facility. So, you know, take into consideration when we're out there shopping or unsure what to do with all our extra money now that we're sober. They're great holiday gifts as well. All right, that's all for this month. Thank you for letting me be of service.

I guess the convention is no longer at the end of April, on Easter.
