It's hard to believe that the first year of my Panel 74 DCMC 2-year term has already passed. It was a year filled with lots of learning experiences.

As a District, our year consisted of the following:

- Twelve (12) steering committee meetings,
- Twelve (12) GSR meetings,
- The 74th GSC Agenda Items,
- District 5's June "Delegate Report Back/Shareback" meeting with Districts 1 & 3 virtually participating,
- Hosting of the Area's September 8th's ASA meeting, and
- A District 5 Inventory

During that timeframe, our average meeting attendance was
